# Index Overview

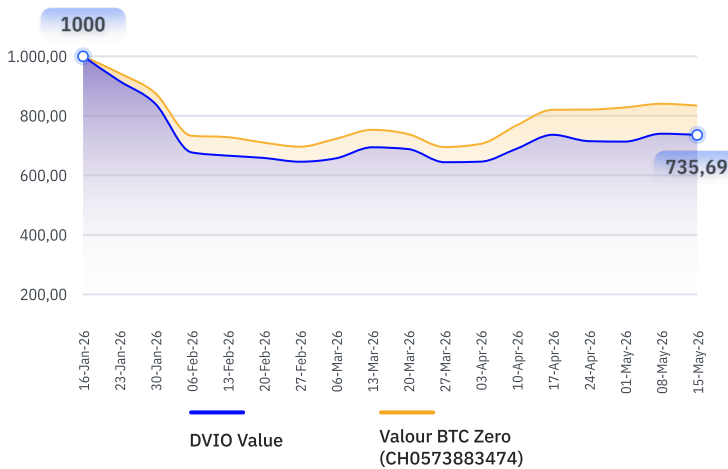
Weekly Report (May 15, 2026)

Each constituent represents real, regulated investor capital, with index weights adjusted weekly to reflect changes in capital allocation and net flows.

- The top 5 assets by inflows accounted for 58,62% of total weekly inflows, highlighting a highly concentrated allocation trend.
- XRP alone represented 16,06% of aggregate inflows, underscoring continued investor preference for flagship digital assets during the period.

## DVIO Altcoin Barometer (DAB)

- **Outcome:** Altcoin Season
- **Commentary:** During last week, altcoins within the index experienced significant net inflows, while Bitcoin ETPs recorded relatively limited net inflows over the same period, indicating broader market participation and a rotation of capital toward higher-beta digital assets.

$$DAB = (\text{Non-BTC flows} - \text{BTC flows}) / \text{Total flows}$$
