Index Overview

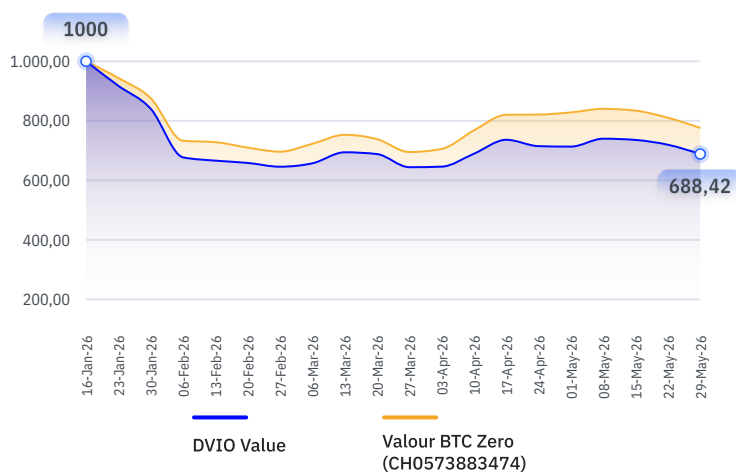
Weekly Report (May 29, 2026)

Each constituent represents real, regulated investor capital, with index weights adjusted weekly to reflect changes in capital allocation and net flows.

- The top 5 assets by inflows accounted for 72,80% of total weekly inflows, highlighting a highly concentrated allocation trend.
- Ethereum alone represented 32,16% of aggregate inflows, underscoring continued investor preference for flagship digital assets during the period.

DVIO Altcoin Barometer (DAB)

- **Outcome:** Altcoin Season
- **Commentary:** During last week, altcoins within the index experienced significant net inflows, while Bitcoin ETPs recorded relatively limited net inflows over the same period, indicating broader market participation and a rotation of capital toward higher-beta digital assets.

Methodology: Every week we compare net flows into the Bitcoin and Altcoin pools as a share of their AUM. The pool with the higher relative flows sets the regime for the week: Bitcoin Dominance or Altcoin Season.
